2. If client takes position in approved scrip basket and the stock is non FNO stock then the margin charged would be approx 16% or actual VAR + ELM, which ever is higher
3. These positions are essentially cut-off by predefined cut-off time, however such positions may be liquidated by the Risk department of RSL due to margin shortfall.
4. The facility is available only in specific scrip basket defined by Reliance Securities from time to time.
5. The scrip basket can change any time depending on volumes and risk parameters set by Reliance Securities.
6. This facility can be withdrawn any time by Reliance securities for any adverse market conditions.
7. For any intraday or carry over loss, I/we am/are fully responsible and will pay the entire amount as appearing in bills and ledger. If amount is not paid till T+2 days, Delayed payment charges @ 18% P.a. from T+2 day onwards will be levied to my account.
